- Dermathohistopathology training: Biweekly with Erin Locke, DVM, DVSc, Diplomat ACVP, Chair of Dermatopathology service, Anatomic Pathologist, Antech Diagnostics. This will be virtual throughout the year, with at least one week of in-person training with Dr. Locke.
- iv. Basic science learning rounds: Once monthly or biweekly for a minimum of 4 hours (based on in clinic schedule) with Becky Valentine, DVM, MS, DACVD[®]. Working through textbooks and online resources, there will be a structured course outline for the study of all basic and applied sciences related to dermatology. Areas of study will include genetics, biochemistry, embryology, anatomy and physiology of skin and adnexal structures, pathomechanisms of dermatological diseases, immunology, bacteriology, mycology, virology, parasitology, internal medicine, nutrition, oncology, pharmacology, clinical pathology, dermatohistopathology, and comparative dermatology. The breadth and depth of study will be sufficient to assure the resident has a firm foundation and is prepared for the ACVD Certifying Examination.
